If you cancel, any payment you have made and any negotiable instrument signed by you shall be returned to you within 30 days following the school's receipt of your cancellation notice.

However, if the school gave you any equipment, you must return the unopened equipment within 30 days of the date you signed a cancellation notice. If you do not return the equipment within this 30-day period, the school may keep an amount of what you paid that equals the cost of the equipment. The total amount charged each item of equipment shall be separately stated. The amount charged for each item shall not exceed the fair market value of the equipment. The school is required to refund any amount over that as provided above, and you may keep the equipment.

To cancel the contract for school, mail or deliver a signed and dated copy of your cancellation notice, or send a telegram to:

REMEMBER, YOU MUST CANCEL IN WRITING.

You do not have the right to cancel by just telephoning the school or by not coming to class.
